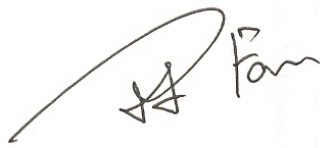

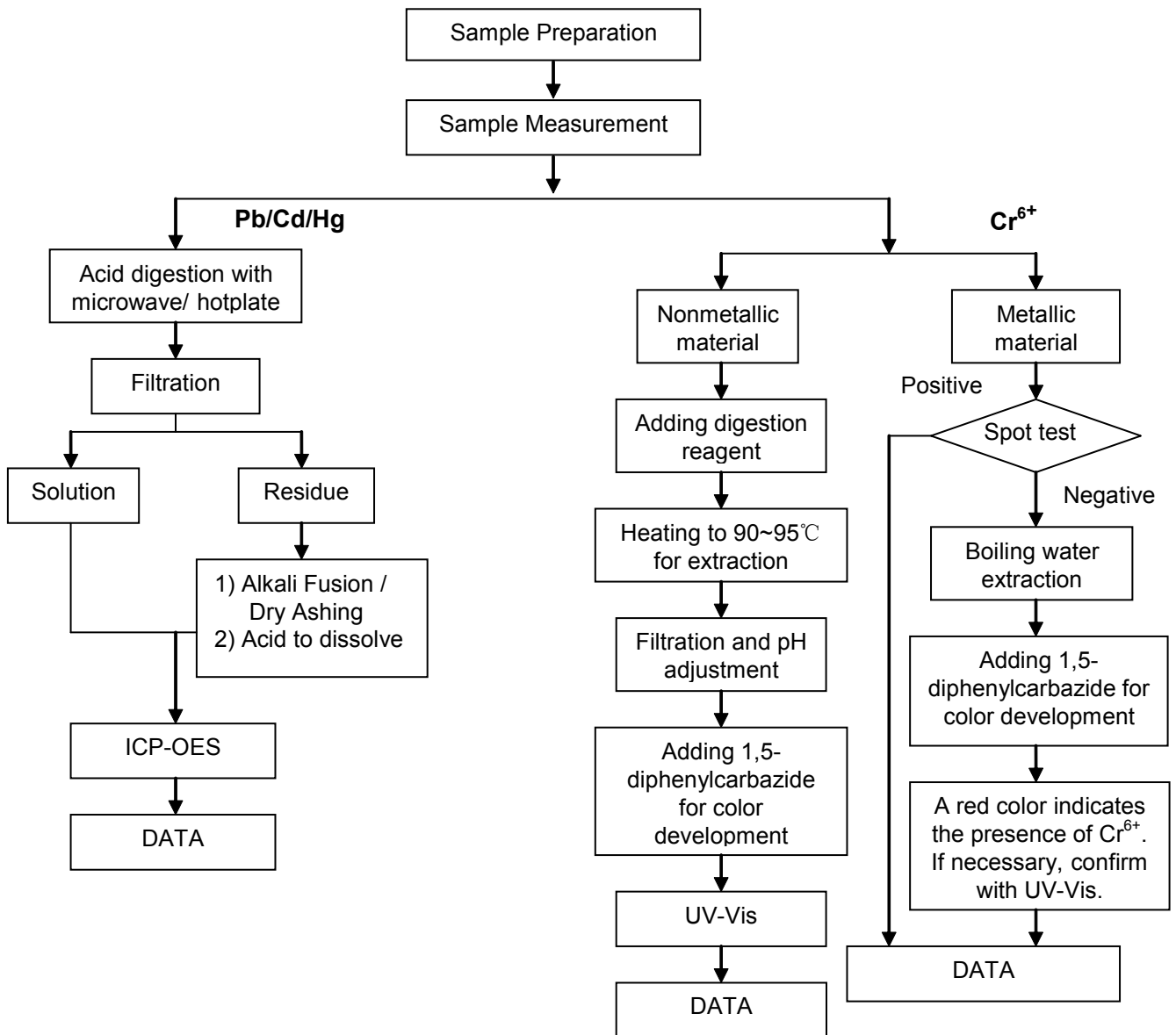

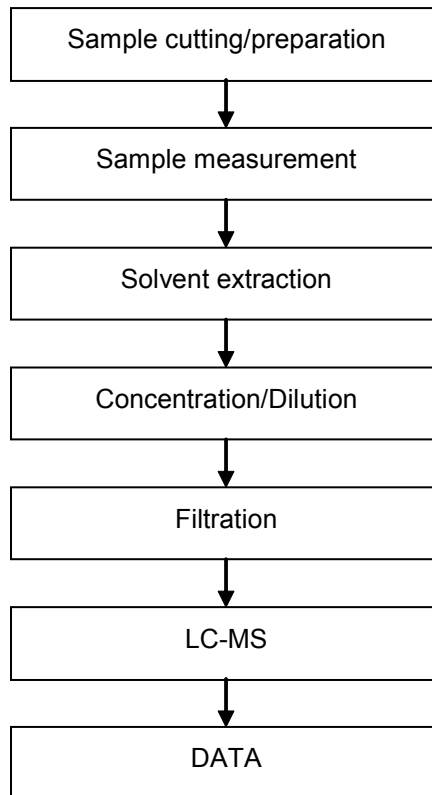

PFOS/PFOA Testing Flow Chart

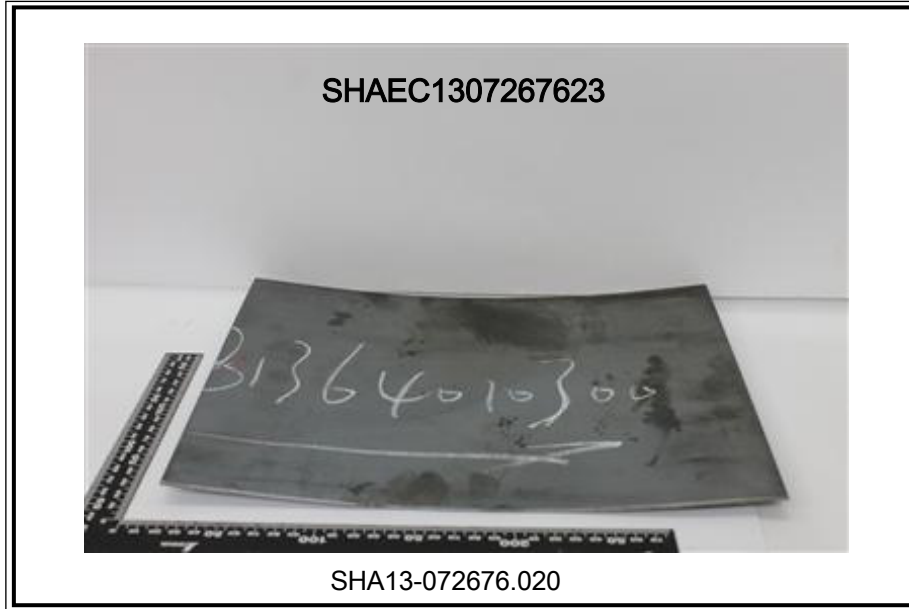
