

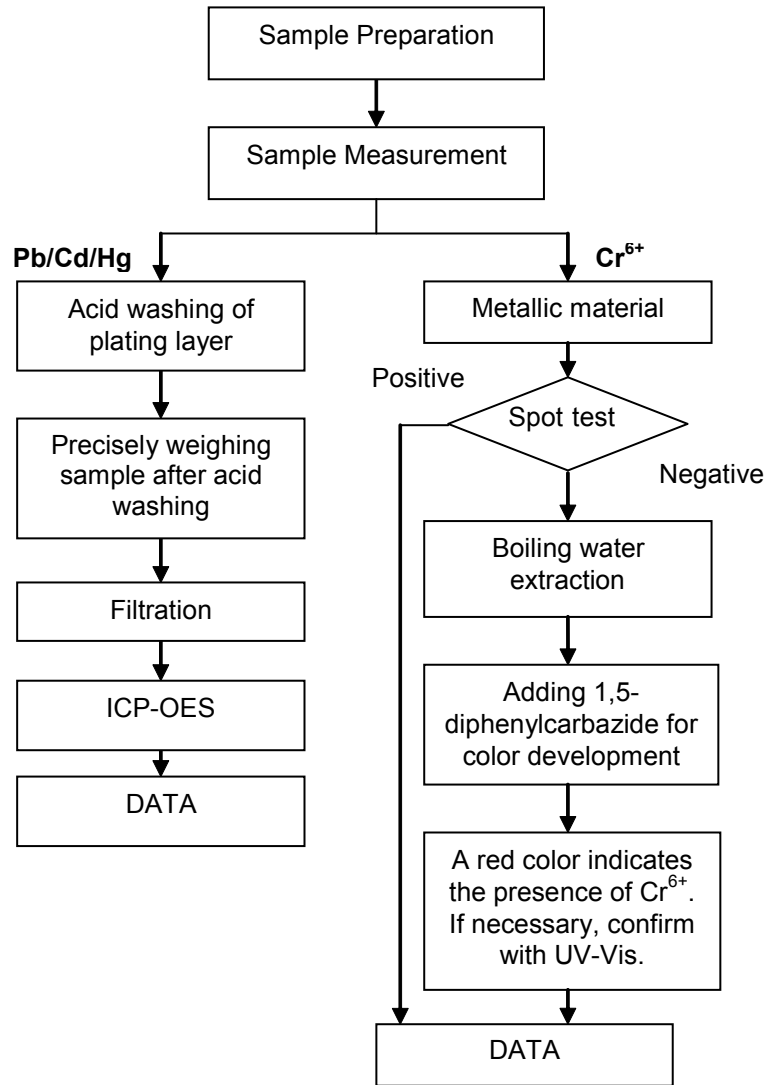

- 3) Acid washing testing of Pb, Cd and Hg reach total dissolution

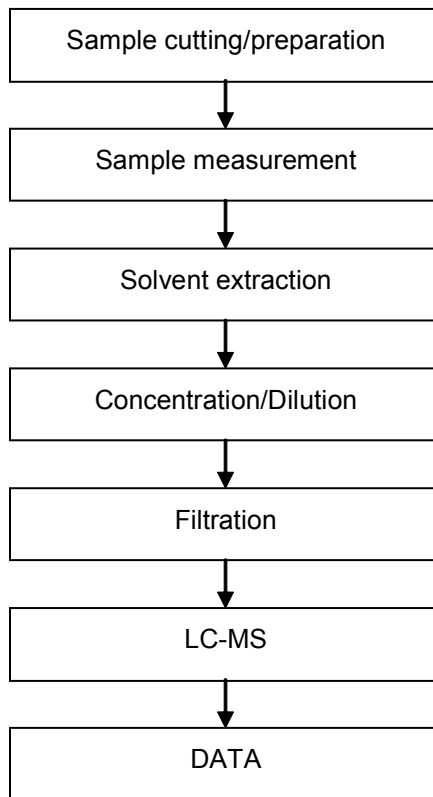

PFOS/PFOA Testing Flow Chart

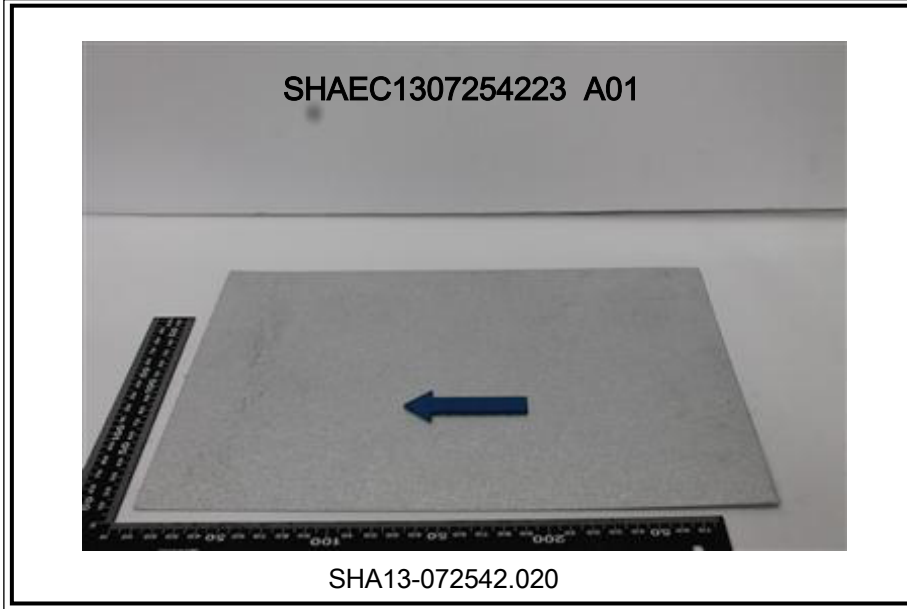
